

Dear Dr. XXXXX,

XXXXX Health Center would like to extend a letter of intent representing a potential employment agreement between XXXXX Health Center (Hospital) and (Physician), collectively referred to as the Parties. The Parties understand that a potential employment agreement may be offered to Physician during the course of the 2014 summer months. This letter of intent is to set forth the basics terms around potential relationships between the Hospital and Physician to support the delivery of health services to members of the Hospital's service area.

This letter of intent is not a contract between the parties; rather, it is a non-binding expression of terms by both parties. The terms and conditions of final definitive agreements supersede all terms and conditions represented here.

- I. **Practice Affiliation and Arrangement**. Whereas, the Hospital and Physician desire an employment relationship that would allow the Physician to render SPECIALTY services in the area. This position does require Physician to take hospital call on an even frequency with other employed or contracted general surgeons on staff at the Hospital. Anticipated call frequency will be 1:3 with a potential agreement for the Hospital to provide locums' coverage during a set number of weekends throughout the contract year. The Hospital desires this position to fulfill outreach capabilities, providing general surgery clinic hours in surrounding cities of the area.
- II. **Terms of Employment**. It is anticipated that the Physician will complete a General Surgery Residency program in July 2015. The Hospital and Physician may enter into a contractual agreement prior to the anticipated completion of the residency program and that an anticipated practice start date will be agreed upon. Physician's employment is contingent upon the successful completion of a post-offer physical examination, drug screen, background checks, and credentialing process.

III.	Compensation and Benefits. The Hospital shall provide a monthly stipend
	during the remainder of the Physician's residency program in the amount of
	This stipend should commence after the Parties enter into a
	contractual employment agreement. Upon completion of the residency program
	and upon the Physician's practice start date, the Physician can expect an annual
	base compensation for 1.0 FTE general surgery services in the amount of
	Physician is entitled to all benefits made available to full time
	employees. Physician shall also receive a community membership allowance in
	the amount not to exceed per year and a continuing education
	allowance in the amount not to exceed per year. Additionally,
	Hospital shall pay to Physician an initial salary signing bonus in an amount
	Half of the signing bonus shall be paid to Physician upon mutual
	signatures of an employment contract. The remaining shall be paid to Physician
	on the first day of practice at the Hospital. Physician and Hospital understand



	there is additional compensation offered through a quarterly production bonus. Further, Hospital agrees to provide of earned time to be used for vacation, personal time or continuing education, during the first year the agreement is in place. Sick or extended illness time shall be given in the amount of per year and not to exceed a maximum of Hospital agrees to provide Physician with an iPhone.
ΙV	Stand-Still Agreement. The Parties agree to negotiate exclusively with each from the date of acceptance of this document. It is agreed that if Hospital or Physician shall want to proceed with negotiations with outside parties, than Hospital or Physician shall communicate in writing with each other regarding other potential employment arrangements to provide or receive general surgery services.
	It is our hope that the above information satisfactorily addresses the needs of both parties If these terms are agreeable, please sign below. This Letter of Intent becomes null and void if not accepted and returned to XXXX Health Center by April 1, 2014.
