Registered Apprenticeship Program (RAP)

Registered apprenticeship programs (RAPs) help businesses develop highlyskilled employees. Upon completion of the program, graduates receive a **national industry-recognized credential** from the U.S. Department of Labor.

Apprenticeship programs also reduce turnover rates, increase productivity and lower the cost of recruitment.

A RAP is a systematic approach to training that ensures employees are trained and certified to produce at the highest skill levels required for the occupation.

Finally, businesses may qualify for funding, tuition assistance and state-based tax credits. These benefits reduce an employer's investment in apprenticeship training costs.

Industry Intermediary: Industry Intermediaries are organizations uniquely positioned to convene employers within an industry or sub-sector to determine skill needs and workforce trends and to work with employers on a regional and national level to develop apprenticeship programs with the goal of increasing the number of apprenticeship opportunities.

National Program Sponsor: An organization that operates a Registered Apprenticeship Program. This entity assumes the full responsibility for administration and operation of the apprenticeship program.
